- 6.2** Ffioedd Claddu yng Ngharreglefn – Trafodwyd ei fod yn anodd cymharu costau mynwentydd gyda'i gilydd a gan nad oes llawer o gladdu ym mynwent Carreglefn, penderfynwyd yn unfrydol i gadw y costau fel ag y maent.
Burial Fees in Carreglefn – It was discussed that it is difficult to compare burial costs to other cemeteries and because there is not many burials at Carreglefn cemetery, it was decided unanimously to keep the costs as they are.
- 6.3** Derbynwyd llythyr gan Mrs Jenny Raffle yn gwneud cais i fod yn aelod o'r Cyngor Cymuned. Gan fod dau sedd wag yng Ngharreglefn ac un yn Llanfechell, penderfynwyd yn unfrydol i'w chyf-ethol.
Gweithred – Y Clerc i ysgrifennu i CSYM i'w wneud yn ymwybodol bod y Cyngor Cymuned wedi cyf-ethol Mrs Jenny Raffle.
A letter was received from Mrs Jenny Raffle with an application to become a member of the Community Council. As there are two vacant seats in Carreglefn and one in Llanfechell, it was decided unanimously to co-opt.
Action – The Clerk to write to IOACC to inform them that the Community Council have co-opted Mrs Jenny Raffle.

A letter was received from Mr Alun Foulkes proposing and willing to complete the annual audit of the Council's respective accounts following the retirement of Mr John Roberts. It was discussed and decided that as the Council has had no other proposal they would accept the offer from Mr Alun Foulkes to undertake the work.

- Ysgol Carreglefn School (Agor a cau / - Opening and closing) – Gan ei fod o fudd i'r gymuned gyfan, trafodwyd a cytunwyd i roi cymorth ariannol o Gronfa'r Melinau Gwynt / As it was of benefit to the whole community, it was discussed and decided to contribute from the Windmill Fund - **£607.50**
- Clwb y Gen (Cyfraniad tuag at y Clwb / Contribution towards the Club) - Gan ei fod o fudd i aelodau hŷn y gymuned gyfan, trafodwyd a cytunwyd i roi cymorth ariannol o Gronfa'r Melinau Gwynt / As it was of benefit to the older people of the community, it was discussed and decided to contribute from the Windmill Fund - **£84**
- Capel Ebeneser (Torri glaswellt y fynwent / Cutting of the cemetery grass) – Gan fod nifer o aelodau y gymuned wedi ei claddu yn y fynwent, trafodwyd a cytunwyd i roi cymorth ariannol o Gronfa'r Melinau Gwynt / As quite a few members of the community are buried in the cemetery, it was discussed and decided to contribute from the Windmill Fund - **£200**

7.4 Presept – Trafodwyd a cytunwyd i godi y presept o 2% i gyd fynd a costau gweinyddol ychwanegol megis cyflog y clerc, yswiriant, costau hyfforddiant / lwfansau i'r Cynghorwyr a'r Clerc a.y.y.b. Mae'r Cyngor Cymuned yn rhagweld costau ychwanegol hefyd gyda torri glaswellt a gwaith angen i'w wneud yn mynwentydd y plwyf. Mae hyn yn gynyddiad o £8,701.48 y flwyddyn i £8,875.51. Pawb yn gytûn yn unfrydol.
Precept – It was discussed and decided to increase the precept by 2% due to additional administrative costs such as clerk's payroll, insurance, training / allowances costs for the Councillors and the Clerk etc. The Community Council also foresee additional costs with grass cutting and work needing to be done with the cemeteries in the ward. This is an increase from £8,701.48 a year to £8,875.51. Everyone in unanimous agreement.
