## **Mechell Community Council**

Minutes of the meeting held on Monday 8<sup>th</sup> September in Llanfechell School 7pm.

In the absence of the Chair person, the meeting was chaired by the Vice-Chair Elin Wynne who welcomed everyone that was present.

### **1. Minutes of the last meeting**

The minutes were accepted as a true record. M Owen proposed and J Jones seconded.

### **2. Matters arising**

2.1 Cutting of footpaths – T Jones asked if there was a possibility to obtain contact details of the individual who has been cutting the footpaths recently as there's a footpath in Mynydd that needs to be cut. It was understood that D Griffith-Jones had thanked the individual for their work however, clarification from the Clerk was needed to see if an official note had been sent. It was understood that M Hughes had already arranged with Carwyn that the footpath in question will be cut.

2.2 Scottish Power – it was noted that there were two items numbered 5 in the minutes. Scottish Power matters have now been resolved and the County Council have accepted responsibility for the running costs, therefore there should be no future bills for the Community Council.

2.4 Street Lighting – the lamps have been upgraded. It was agreed that the lights are just as effective as the previous ones and the members were not aware of any problems that had arisen.

2.5 Highways – still no response as of yet, it was agreed to discuss again when further information is at hand.
